ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION/ORGANIZATION OF
ST. SIMEON "THE MYRRH FLOWING" SERBIAN ORTHODOX CHURCH PARISH OF SOUTH FLORIDA,
INC.

Pursuant to the provisions of FS § 617.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is ST. SIMEON "THE MYRRH FLOWING" SERBIAN ORTHODOX CHURCH PARISH OF SOUTH FLORIDA, INC. Articles of incorporation for this corporation were filed on 06/06/1980 and assigned Florida document number 752823.

2. The following amendments (which shall be effective as of the date of filing) of the articles of incorporation were adopted by the board of trustees of the corporation on April 10, 2015 in the manner prescribed by the Florida Not for Profit Corporation Act and is sufficient for approval:

Article III of the Articles of incorporation (subpart: GENERAL PURPOSE) is deleted and replaced with the following:

GENERAL PURPOSE

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The Corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by political campaign on behalf of any candidate for public office).

Article X of the Articles of incorporation (First paragraph only) is deleted and replaced with the following:

In the event that members of the parish can no longer support the parish priest, or that the majority of the people move to another area, then the property and all possessions and assets will be distributed to the Serbian Orthodox Diocese of Eastern America and Canada, or its successors, an exempt organization, in trust, for the purpose of establishing a Serbian Orthodox Parish in the area where the majority have moved, which Parish would then assume control and possession of said assets. If this proves unsuccessful within five years, then after such time, the assets would be transferred to the Serbian Orthodox Diocese of Eastern America and Canada, or its successors, for one or more purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or if none of the above apply, the assets shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
