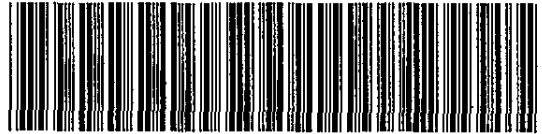

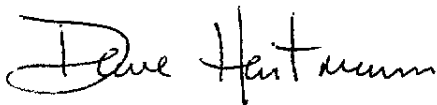

The undersigned, Stuart Kuehl, as president of NEW BEGINNINGS CHRISTIAN CHURCH, INC., a Florida corporation not for profit (the "Corporation"), does hereby certify that : 1) a special meeting of the Board of Directors and members of the Corporation was duly called as specified under article 3, section 1, of the by-laws adopted on December 8, 2003, and held at the principle office of the Corporation at 7726 Canterbury Circle, Lakeland, Polk County, Florida, on January 8, 2006; 2) the following resolutions were adopted at said meeting by unanimous vote of the Board of Directors of the Corporation; and 3) the following resolutions were adopted, ratified, approved, and confirmed by unanimous vote at said meeting by the members of the Corporation.
