1. To study, teach and publish the traditional role of political, religious and economic Social MEMES continual Waring, Malicious violence and the destruction of Human Civilizations.
2. To preach, teach and publish the COMPLETE "Gospel of God" which is the Equality of ALL Persons, of ALL faiths, Cultures and Nations; challenging churches, synagogues and mosques to stand openly against social evils such as slavery, segregation and unequal treatment fostered by their own authorities and systems. In the U.S. it was 30 years after the civil rights struggle, before Jack Hayford, a leader of White Pentecostal national churches, to apologize to the Black churches of the same ilk for "White Christianity's deafening silence" during that struggle." In South Africa, the predominant religious body, the Dutch Reform Church, was a partner in keeping apartheid alive. In the 1930s - 40s' German Lutherans supported Hitler until the end. This has been the normal stand of organized religion since ancient times. The Hebrew Prophets' main adversary, always attempting to silence God's messengers, were the Temple Prophets and later with Jesus it was the Sadducees Party that condemned him to the death for supporting the poor. This Godless behavior must stop if religious communities are to survive. (The entire N.T.; Acts 10:34; H.S. Elijah to Malachi) - UN/Decl. of HR Article ONE).
3. To reintroduce the doctrines of Righteousness, Holiness and broad-based Morality to ALL people, religions and global communities. This, not just for individual persons, but to expect these same Moral Behavior requirements from all human institutions (Social Memes): churches, economic systems and civil institutions. In past ages, these moral demands have been seen as the responsibly of individual people, while Social Memes, the chief violators of human civilization, have been protected from these rules of righteous, godly behaviors.
4. To emphasize that ALL religions, governments and societies understand: FEAR, especially "Social Paranoia," separating peoples, operating covertly, scheming connivance, keeping populations ignorant and misinformed, promoting unauthentic false and stealth information in order to achieve a superior position over others, is TOTALLY responsible for War, pernicious extraction of assets, poverty, slavery and destruction of human civilization.
5. To advance the ethic: "Together Everyone Accomplishes More" (TEAM). We believe the world is a tapestry of differing races, cultures, customs and languages, all working in concert. Traditional teachings that "people gathered" is the source of EVIL, unavoidable and normal, many teaching God introduced and sanctioned, is a LIE! The antidote for this fatalism is the EXPOSURE of inequality, unfairness, hoarding, greed, hate, racism, disrespect of OTHERS and for our planet home and its bounty (God placed us as "REPLENISHER" (Gen 1) not "depletors").
6. To encourage leadership, in all disciplines, in truth telling, openness and the acceptance of all - by all. We advocate for bottom-up leaders, whose FIRST RESPONSIBILITY is to those in her/his care, NOT to powerful political, economic and religious hierarchy.
7. To operate as a safe place, where people of ALL faiths interested in the ideal - PEACE filled world, can gather and impact the world with these highest of values, literally a meeting sanctuary for ALL the "People of God."
8. RI is a Florida chartered non-profit corporation licensed as a 501 (c) (3) tax exempt organization by the IRS. We will sponsor NO political party or candidate; our focus is to critique all governing philosophies-civil, religious and economic. We shall NOT violate the Johnson Act of the U.S. Tax Code ('64). Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed shall be disposed of by a court

ARTICLE XI: (History)

The Renaissance Institute was founded in 1992 as a result of human civilization's facing massive changes in political, religious and economic dynamics the world over. Formerly subjugated peoples were finding a place in society. While, countries were attempting to come together to face oppressive governments.

Caught in the forefront of that human rights struggle for advanced all-inclusive cultures, our founder Britt Minshall had labored through 40-years of study, documenting Human behavior patterns.

He was born to a split family. One side was successful in business, High Methodist and well known, having arrived in America in 1682, before William Penn, a founding family of the State of Pennsylvania.

The other side were mill workers, poorer and less educated, devout Christian Methodist Holiness (plain people). They were extremely modest in their pursuits. Britt spent equal time between both groups.

When he was nine years-old when he came face to face with racial bigotry and White privilege domination, unfortunately at the family's church. Naturally his anger turned straight on God.

In spite of his anger, in March 1975 (Age 32), his children "tricked" him into seeing a Johnny Cash movie, The Gospel Road, where Jesus was portrayed walking along the Sea of Galilee. Then little children ran to him as he laughingly hoisted them up to himself: "They were Black, White and Yellow; every kind of kid on earth." Britt reacted: "OH my God what have I done. I have blamed God for what people did!"

Having no religious experience, he got down on his knees outside the church, and yelled as loud as possible: "God Is It Too Late for me!" Next, he recounts hearing a voice "no my son welcome home." So it was, over the next twelve years, Britt was moved to minister as a missionary, evangelist, pastor, Chaplin and theology student, most with no pay or support. He served in small churches, hospitals, hospice unites, inner cities and prisons. Additionally, Britt completed seventeen mission trips to Haiti, serving among the poorest people in Port-au-Prince and in Abrcote, Jacmel and Fonds Priseon. He also made several trips in residence at a home for severely disabled children in Penton-Ville.

Gradually, from these formative experiences, arose a man of God who was an unusual combination of Christian Holiness and Enlightenment Social Activist World Changer. His demand of Christians "TRUTH in all things, decisions based on FACT, not wild emotions, devoutly following God's most basic precepts of: LOVE for GOD and LOVE, RESPECT

and EQUALITY of everyone." Also, we should live in PEACE with the same CONSIDERATION for ALL OTHERS as we hold for ourselves. THERE CAN NEVER BE AN EXCEPTION!

The Methodist Holiness had survived! Now that's combined with his *advanced degrees* culminating with a Doctorate from Boston University ('92), a dedication to teaching righteousness and social change through the Holy Spirit. His lifelong support of the United Nations as humanity's greatest achievement continues. He remains a stalwart opponent of WAR behaviors - truly a Social Activist Ministry, forever ensconced in the Renaissance Institute of American Churches, Inc.






