

ARTICLES OF DISSOLUTION
OF

LEARN TO READ VOLUNTEERS OF BROWARD COUNTY, INC.

Pursuant to Chapter 617, Florida Statutes, commonly known and referred to as the "Florida Not For Profit Corporation Act", LEARN TO READ VOLUNTEERS OF BROWARD COUNTY, INC., a Florida corporation not for profit, has, through its directors adopted the following Articles of Dissolution:

ARTICLE I. NAME OF CORPORATION

The name of the corporation is LEARN TO READ VOLUNTEERS OF BROWARD COUNTY, INC., a Florida corporation not for profit.

ARTICLE II. DATE DISSOLUTION AUTHORIZED BY MEMBERS

On JUNE 6, 1997 a majority of the members of LEARN TO READ VOLUNTEERS OF BROWARD COUNTY, INC., who were present and entitled to vote at a special meeting, adopted a resolution authorizing the dissolution of the corporation, forthwith.

ARTICLE III. NUMBER CAST FOR DISSOLUTION
