## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR THE COMMUNITY PRESBYTERIAN CHURCH OF CLEWISTON, FLORIDA, IN THE UNITED STATES OF AMERICA

Revised: 10/20/13 – Effective: 10/28/13

- 1. The Community Presbyterian Church of Clewiston, Florida, being a particular congregation of the Evangelical Presbyterian Church recognizes that the Constitution of said Church is in all its provision obligatory upon it and its members.
- 2. There shall be an Annual Meeting of the Congregation in the church building in December for the transaction of any business properly coming before such meeting.
- 3. Special meetings may be called by the Unicameral Board (the Board of Session acting at the same time as the Trustees of the Corporation), by the Unicameral Board at the request of at least 10% of the active membership, or by the Presbytery. Such calls shall state clearly the purpose of such special meeting, and no other matter save that specified in the call may be considered.
- 4. Public notice of time, place, and purpose of all meetings of the congregation shall be given at least two Sundays prior to the appointed time.
- 5. The pastor shall preside. If the church is vacant or if the pastor and the Unicameral Board agree that the subjects to be discussed require it, or if the pastor is ill or is otherwise unable to be present, a minister of this church's presbytery shall be invited by the Unicameral Board to preside. This invitation shall be cleared through Presbytery.
- 6. The clerk of the Unicameral Board shall be secretary of the meetings of the congregation. If unable to attend, the Unicameral Board shall designate a secretary in his or her stead.
- 7. All members in good and regular standing shall be entitled to vote at congregational meetings.
- 8. As required by the Laws of the State of Florida, only members of full age (18 years) shall be eligible to vote on questions dealing with property and matters that are strictly the business of the corporation. Otherwise, all active members of the church are eligible to vote at all stated and special meetings of the church. Voting by proxy is not allowed.
- 9. Meetings shall be conducted in accordance with the General Rules for Courts of the Church adopted by the General Assembly of the Evangelical Presbyterian Church, so far as they apply, and when they do not apply, according to Roberts Rules of Order.
- 10. All meetings shall be opened and closed with prayer.
- 11. A quorum for congregational meetings shall consist of 1/5 (20%) of the active membership.

- 12. There shall be five (5) members of the Unicameral Board divided into three classes, one class of who shall be elected each year at the Annual meeting for a three year term. No unicameral Board member shall serve on the board for consecutive term, either full or partial, aggregating more than six (6) years; but shall be ineligible to be elected to a new term until one (1) year shall have elapsed. The Nominating Committee shall develop three equal classes.
- 13. There shall be five (5) deacons divided into a three classes, one class of whom shall de elected each year at the Annual meeting for a three-year term. One deacon shall serve on the Board of Deacons for consecutive terms, either full of partial, aggregating more than five (5) years; but shall be ineligible to be elected to a new term until one (1) year shall have elapsed. (Amended 12/09)
- 14. Vacancies on the Unicameral Board or Board of Deacons may be filled at a special meeting of the congregation or at the Annual meeting, as the Unicameral Board may determine.
- 15. The pastor shall be, ex officio president of the Unicameral Board, and the clerk of the Unicameral Board shall be ex officio, secretary of the Unicameral Board. The Unicameral Board shall appoint annually a church treasurer.
- 16. A quorum for the Unicameral Board meeting shall be three (3) Unicameral Board members with the pastor.
- 17. There shall be a representative nominating committee chosen in accordance with the form of Government. The committee shall bring to the annual meeting nominations of one eligible person only for each office to be filled. Additional nominations of qualified persons may be made from the floor by any eligible voter.
- 18. These By-Laws may be amended subject to the charter of the corporation, the laws of the State of Florida, and the Constitution of the Evangelical Presbyterian Church at the annual meeting or at any special meeting by a two-third vote of the active members present, provided that a full reading of the proposed changes or a printed distribution of the same shall have been made in connection with the call of the meeting.
- 19. These By-Laws or the charter of this corporation may not be amended contrary to or so as not to include the provisions of the Constitution of the Evangelical Presbyterian Church.
- 20. Should any provision of these BYLAWS be determined to be in conflict with the Constitution of the Evangelical Presbyterian Church (EPC), the constitutional provisions will prevail.
