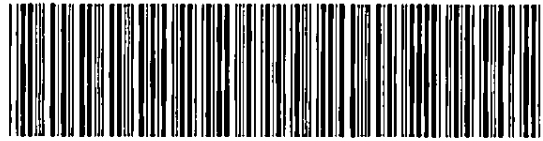

1. Section 5.2 of the Restated Articles of Incorporation of Cypress Village Property Owners Association, Inc., shall be amended to read as follows:

5.2 Voting Rights. Each parcel owner shall be entitled to one vote for each parcel owned. The term parcel shall include lots and condominium units. ~~If a parcel is owned by more than one person or entity, such owner shall designate one of their members as the voting member, and shall give the Association notice in writing of the owner so selected. Fractional voting shall not be permitted, and failure on the part of multiple owners of a single parcel to so notify the Association shall result in the loss of the vote for that particular parcel until such time as the required notice has been given to the Association.~~

2. Article XI, Registered Office and Resident Agent, of the Restated Articles of Incorporation of Cypress Village Property Owners Association, Inc., shall be amended to read as follows:

Article XI. Registered Office and Resident Agent. The office of the Association shall be located at 108 Cypress Blvd. West, Homosassa, FL, 34446 and the resident agent present at such office and upon who process may be served shall be John J. Codogan the current Community Association Manager.
