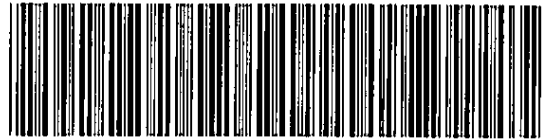

CERTIFICATE FOR REINCORPORATION AND AMENDED
ARTICLES OF INCORPORATION OF MCGREGOR BAPTIST CHURCH, INC.

This certifies that McGregor Baptist Church was chartered as a corporation by a Lee County Circuit Judge, the Honorable Archie Odom, on the 29th day of October, 1958, (a copy of its Charter is attached hereto as Exhibit "A"), and, pursuant to Florida Statute 617.012 for the purpose of reincorporation, this certificate and the certified copy of the Charter of the McGregor Baptist Church, there having been no amendments, is hereby filed with the Department of State.

Pursuant to Florida Statutes 617.012 and 617.013, the following information is hereby provided to the Department of State and stated as the Amended Articles of Incorporation of McGregor Baptist Church, Inc.

1. The name of the corporation after reincorporation shall be McGregor Baptist Church, Inc.

2. The issuance of this certificate for reincorporation and amended articles of incorporation of McGregor Baptist Church, Inc. was authorized by meeting of its members regularly called and it is intended that upon the filing hereof, that this corporation shall be deemed to be incorporated under the provisions of Chapter 617, Florida Statutes, and that this certificate of reincorporation and amended articles of incorporation of McGregor Baptist Church, Inc. shall constitute its articles of incorporation under such Statutes.

3. McGregor Baptist Church, Inc., shall have perpetual existence.

4. McGregor Baptist Church, Inc. hereby accepts the provisions of Chapter 617 of the Florida Statutes as from time to time amended, as the governing law of the corporation.

5. The purpose or objective of the McGregor Baptist Church, Inc. is to bring men, women, boys, and girls into a personal trust and acceptance of Jesus Christ as Saviour of their eternal souls and Lord of their entire lives and to encourage their growth to Christian maturity through preaching, teaching, and study of the Word of God.

6. The membership of this church shall consist of such persons as meet the following requirements:

(a) Such person confesses Jesus Christ to be the Saviour and Lord to them and freely enter into the covenant of this church and abide by its by-laws.

(b) Such person has been accepted by a majority vote of the members present at an annual meeting of the corporation or any regularly scheduled Sunday church service.

(c) Such person has not been disqualified as a member by reason of nonattendance, misconduct or violation of any of the by-laws of McGregor Baptist Church, Inc.

The list of church membership as kept by the secretary of the church shall be the final determination of membership in McGregor Baptist Church, Inc. for all purposes unless modified by majority vote of the Board of Deacons. Members on the nonresident list or inactive list as defined by the by-laws of McGregor Baptist Church, Inc. shall not be members of the corporation, although this does not necessarily separate them from the church community.

7. The officers of the corporation shall be:

(a) Chairman, who shall be elected from the deacons by a majority vote of the deacons present at the first regular meeting held after the annual meeting described in paragraph 6.

(b) A Vice-Chairman, who shall preside in the absence of the Chairman and have such other duties as may be established by the by-laws and who is elected in the same manner as the Chairman.

(c) Secretary, whose duties shall include acting as clerk of the church and keeping minutes of all meetings of the membership and shall have such other duties as may be established by the by-laws. The Secretary need not be a deacon and shall be elected by a majority of the members present at the annual meeting.

(d) Treasurer, who shall be responsible for the financial record keeping of the church and handling funds and have such other duties as may be established in the by-laws of the corporation and who shall be elected in the same manner as provided for the Secretary.

(e) An Assistant Treasurer, whose duties shall be to assist the Treasurer and serve in his absence and who shall have such other duties as may be established by law by the by-laws of the corporation and who shall be elected in the same manner as the Secretary.

8. The initial officers under these amended articles of incorporation are.

CHAIRMAN: Joe McLarry

VICE-CHAIRMAN: Clayton Johnson

SECRETARY: Joyce Huntley

TREASURER: Fred Bunnell

ASSISTANT TREASURER: W.W. Watson

9. The Chairman and Vice-Chairman are severally authorized to sign deeds, mortgages, notes and other instruments on behalf of the corporation and shall have the authority of those officers usually designated as President and Vice-President respectively when acting on behalf of the corporation.

10. The Board of Deacons shall consist of not less than five (5) nor more than twenty-five (25) persons. The number of deacons and their qualifications shall be provided for in the by-laws of the corporation. The Board of Deacons may research and prepare recommendations relating to the business affairs and other affairs of the church subject to approval of a majority of the members present at business meetings of the membership of the church. The Board of Deacons may authorize and approve expenditures without such approval up to the maximum established in the by-laws.

Business meetings of the membership of the church may be held on Wednesday evenings or at regular Sunday services, or at such other times as may be designated by the Pastor or the Board of Deacons. The membership shall be notified of the business meeting in the church bulletin for the Sunday preceding the meeting, unless it is held on the second Wednesday of the month or some other regularly scheduled time.

11. Each deacon shall be elected to serve a term of three (3) years. No deacon may serve for more than three (3) consecutive years

and shall not be eligible to serve again within twelve (12) months of terminating his previous service as deacon. One third of the deacons shall be elected each year, together with such other members as are necessary to fill vacant positions which have occurred since Election shall be by majority vote of those members present at a meeting announced in the manner required for a change by-laws.

13. The annual meeting shall be held on the second Wednesday in September of each year, or at such other time as may be established by the by-laws. The location of the annual meeting shall be at McGregor Baptist Church, 5523 McGregor Boulevard, Fort Myers, Florida, or at such other location in Lee County, Florida, as may be specified by a majority vote of the Board of Deacons. Annual meetings may

consider and determine any matter allowed under the provisions of this article. Notice of the annual meeting shall be posted on the church bulletin board at least 28 days prior to such meeting, or be announced to all members at all regular Sunday services for the two Sundays immediately prior to the meeting, either orally or in the church bulletin.

14. Special meetings of the membership may be called by a majority of the Board of Deacons or by a written petition signed by any 100 members of the church. The church secretary shall see that notice of the meeting and the issues to be discussed at the meeting are announced in the church bulletin, by posting on the church bulletin board or by written notice to all members at least seven (7) days prior to the time of the special meeting.

15. The by-laws of the corporation shall be made, altered, or rescinded by a majority vote of the members present at a meeting announced at least seven (7) days in advance by posting on the church bulletin board, placing a notice in the church bulletin or by announcement at all services on a Sunday, said announcement stating the substance of the changes to the by-laws to be considered.

16. Amendments to the articles of incorporation may be proposed and adopted by a two-thirds majority of those present at a meeting which has been called for the purpose of amending the articles of incorporation held not less than seven (7) days after notice has been posted of such meeting and the purpose of the meeting by posting on the church bulletin board, publication in the church bulletin, or mailing of a notice to all members. The secretary of the corporation and the chairman of the corporation shall certify the notice and the results of such meeting and are authorized by the corporation to execute such documents on behalf of the corporation for such amendments to the articles of incorporation to be filed with the Secretary

17. Any purchase of real property by the corporation shall be approved by a majority vote of those members present at a meeting announced at least seven (7) days in advance by posting on the church bulletin board, placing a notice in the church bulletin or by announcement at all services on a Sunday, such notice stating that the purchase of real property is being considered. The indebtedness of the church shall never exceed two-thirds of the value of church property unless such an increase in indebtedness is approved by a majority of the members present at a meeting called in the same manner as required for approving the purchase of real property.

18. The corporation maintains an office at 5523 McGregor Boulevard, Fort Myers, Florida, and its registered agent at such office upon whom process may be served is James O. Holbrook. The residence address of said registered agent is 1001 North Waterway Drive, Fort Myers, Florida 33907.

CHARTER OF SOUTHERN MISSIONARY BAPTIST CHURCH

WE, the undersigned, of the County of _____ State of _____ do hereby certify that we have organized ourselves for the purpose of becoming incorporated under the laws of this State of _____ applicable to corporations of this kind, and we have adopted the following proposed Charter:

ARTICLE I.

The name of the corporation shall be SOUTHERN MISSIONARY BAPTIST CHURCH, and it is to be located in the County of _____ State of _____.

ARTICLE II.

The general nature of the objects of this corporation shall be to conduct for religious worship and instruction, Sunday schools, pastorals, and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith which are most surely held among Southern Missionary Baptist Churches and to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions; and to aid in the spread of the Gospel of Jesus Christ to the ends of the earth; also to educate, prepare and ordain Christian men and women for the ministry of the Gospel of Jesus Christ.

ARTICLE III.

Every person who believes in repentance toward God, and faith in Jesus Christ, as Saviour and Lord, and who is willing to confess Him publicly as Lord and King and follow Him in baptism by immersion, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in this corporation. 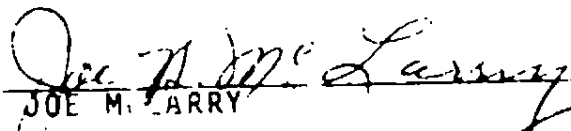
