**ARTICLES OF DISSOLUTION

Pursuant to Section 617.1403 of the Florida Not For Profit Corporation Act (the "Act"), Helen Ellis Memorial Hospital Auxiliary, Inc., a Florida not for profit corporation (the "Corporation"), hereby adopts the following Articles of Dissolution:

**ARTICLE I**

**Name**

The name of the Corporation is Helen Ellis Memorial Hospital Auxiliary, Inc.

**ARTICLE II**

**Filing Date and Document Number**

The Articles of Incorporation of the Corporation were filed on August 1988 and assigned Document Number 753853.

**ARTICLE III**

**Dissolution Approval Date**

The dissolution of the Corporation was approved on March 20, 2024.

**ARTICLE IV**

**Dissolution Authorized**

The Board of Directors of the Corporation duly approved and recommended adoption of the Articles of Dissolution by unanimous written consent effective as of March 20, 2024 in accordance with Section 617.0821 of the Act. **Discharge of Liabilities**

All debts, obligations, and liabilities of the Corporation have been paid or discharged, or adequate provisions have been made therefor.
