The following are Articles of Incorporation executed pursuant to the Florida Corporations, Not-for-Profit Act, Florida Statutes, Ch. 617.

ARTICLE !

The name of this corporation is PALM ISLAND ESTATES ASSOCIATION, INC.

ARTICLE II

The duration of this corporation shall be perpetual. Commencement of this corporation's existence shall be the time of the filling of these Articles of Incorporation by the Department of State of Florida.

ARTICLE III
