The meeting was called to order by Allen & the financial report was distributed by Maureen. We have a balance of \$78.24 in our account. Wanda read the minutes of the previous meeting. Allen motioned to accept the minutes, Charlie seconded and all were in favor.

New business: Our lawn maintenance will be from 4/1 thru 11/30 at \$200. a month with M & M. Allen made a motion to accept, Esther seconded, all were in favor.
