

As used herein the following shall apply:

- C. The original Declaration of Condominium was recorded in Official Records Book 2258, at Page 2243, of the Public Records of Brevard County, Florida.
- 1. The fifth (5th) sentence of Article XII of the Articles of Incorporation shall be amended to read as follows:
  - "... At such meeting the amendment or amendments proposed must be approved by an affirmative vote of the members owning not less then seventy-five (75%)-percent two-thirds (2/3) of the apartment units in the condominium in order for such amendment or amendments to become effective. ..."
