ARTICLE I.

Name

The name of the corporation shall be TEMPLE BETH EL,
INC.

ARTICLE II.

Purpose

The purposes of this corporation shall be:

1. To promote, encourage and sponsor religion; to hold, own, buy, sell, lease, acquire and dispose of any and all kinds of property, real or personal, necessary or expedient in carrying out the general object of this association; to engage in benevolent and charitable objects and social work through its several members and those who may be associated with this organization; and to exercise generally all powers compatible to an organization of the character stated.
2. To exercise any and every right and power that a non-profit religious corporation organized under Chapter 617 of the Florida Statutes could exercise and yet remain exempt from income taxation under the Internal Revenue Code of the United States, including the powers granted to Section 617.021 of said Chapter 617; to act as trustee of the property whenever this corporation has a beneficial, contingent or remainder interest therein, and to hold legal title to property, the beneficial interest of which is owned by any other eleemosynary institution or non-profit corporation or fraternal, benevolent, charitable or religious society or association.

ARTICLE III.

Qualification of Members

1. Persons of the Jewish faith shall be eligible for membership. A candidate for membership shall make application through the Membership Committee. At the recommendation of that

Committee, the application shall be presented at a regular meeting of the Board of Trustees of the Congregation, herein known as the Board, and elected to membership by a majority vote of those present and voting. In the case of interfaith marriages, both parties may be members, except the non-Jewish spouse shall not hold office as Trustee, or any other elective office.

2. There shall be, at least, the following types of membership, although the Board shall have the power to create any additional classifications of membership and to fix the terms and conditions thereof.

(a) Family Membership wherein both husband and wife, with or without dependent children are members or an individual parent, with dependent children, is a member.

(b) Individual Membership wherein any individual over the age of 18 years shall become a member at not less than one-half the regular yearly dues.

(c) Under 25 Membership wherein the head of the household and family is less than 25 years of age. Such membership shall automatically be converted into a Family Membership when the head of the household attains 25 years of age. Such a member shall contribute not less than one-half the regular yearly dues.

(d) Honorary Membership may be conferred by the Board upon any person and upon such terms and conditions as it sees fit. Such a membership shall be granted only by an affirmative vote of two-thirds of the Board present and voting at any regular meeting.

(e) Sustaining Membership wherein members in good standing of the Temple, leaving the area on a permanent basis may apply for such membership at not less than one-third the regular yearly dues and will be entitled to all privileges of membership except the right to vote or hold office, free attendance to High Holy Days services, enrollment in Religious School, and cemetery privileges, unless previously contracted.

(f) Associate Membership wherein an individual or family, not resident in the area on a full time basis, may become members not to exceed six months and not to include the High Holy Days and at not less than one-half the regular yearly dues.

(g) Limited Income Membership wherein a family or individual on Social Security or other type of limited income or pension may become members at a rate to be established as required by the Board. Such members shall have all rights and privileges of Temple membership.

ARTICLE IV.

Term of Existence

This corporation shall exist perpetually unless dissolved by law or as provided by Chapter 617.05, Florida Statutes (or other statutes bearing on such dissolution from time to time) upon a vote of a two-thirds majority of the members present at any meeting called in such manner and after such notice as prescribed in the By-Laws. Upon dissolution of this corporation, no part of its assets shall inure to the benefit of any private individual or organization, but such assets shall inure to such religious, charitable or educational undertaking, institution or agency as is exempt from federal income taxes under the then existing revenue laws of the United States.

ARTICLE V.

ARTICLE VI

Officers

The officers of this corporation shall be a President, a Secretary, a Treasurer and such other officers as may be provided in the By-Laws.

The names of the persons who are presently serving as officers of the corporation until the next annual election are as follows:

PRESIDENT - DR. RAYMOND ISENBURG
FIRST VICE PRESIDENT - ALLEN ROKAW
SECRETARY - HELENE SCHWEIGER
TREASURER - BERNARD RUBIN

The officers of this corporation shall be elected by the membership of the corporation at its annual meeting and shall serve in the manner provided in the By-Laws.

ARTICLE VII

Board of Trustees

1. The property, affairs, business and concerns of the Congregation shall be in the charge, control and management of the Board, and shall specifically include the power to secure, fix compensation for, and dispense with the services of all personnel relating to all services and facilities to and for the Congregation subject to a budget previously approved by the Congregation; and such personnel shall serve at the pleasure of the Board.

2. The Board of Trustees, all of whom must be members of the Congregation in good standing, shall begin their term of office in June. Installation of officers and trustees shall be held in June. The Board of Trustees will be constituted in the following manner:

(a) Twelve members shall be divided into two equal groups of six and shall be elected, as previously provided for, to serve for a period of two years, one group of six being elected at each General Meeting in May.

(b) The thirteenth Trustee shall be the immediate outgoing President, unless such member shall not have completed his term as a Trustee. In such event this Board position will be filled, by election, at the General Meeting in May.

(c) The fourteenth Trustee shall be the Temple Sisterhood President or a designated representative and the fifteenth shall be an "at large" member recommended by the President for approval by the Board of Trustees. In the event a viable Brotherhood be formed - the President shall be the fifteenth Trustee.

(d) The sixteenth Trustee shall be the Board appointed Chairperson of the Board of Education and enjoy all rights and privileges of a Board member.

(e) Other individuals may be appointed by the President, from time to time, serving at the pleasure of the Board, to sit on the Board as ex-officio members, but without voting privileges.

3. The Board shall meet on a regular monthly basis, but optionally in the months of July and August. The date, time and place shall be set by the Board and seven days written notification shall be given to all Board Members.

4. Special Meetings of the Board may be called at the discretion of the President or by the formal request of three Board Members with seven days written notification, specifying the purposes of such a meeting, being given to all Board Members. No business other than that specified shall be transacted at any Special Meeting of the Board.

5. At any meeting of the Board a majority of the entire Board shall constitute a quorum.

6. The President may postpone any meeting of the Board, but for no longer than ten days.

7. The seat of any Board Member shall be deemed vacant if the individual ceases to be a member in good standing of the Congregation or is subject to automatic removal from the Board if absent from three consecutive regular Board meetings without just cause.

8. Vacancies shall be filled expeditiously in accordance with the following procedure. Where the vacancy is a seat filled by appointment of the President, he shall appoint a successor. Where the vacancy is a seat elected by the General Membership, it shall be filled by the Board. Where the vacancy is a seat occupied by a member of a subsidiary organization, the seat shall be filled by the organization.

ARTICLE VIII.

By-Laws

The membership of this corporation shall provide such By-Laws for the conduct of this business and the carrying out of its purposes as they, from time to time, may deem necessary.

Amendments to the By-Laws of this religious corporation may be proposed by the Board of Trustees and may only be adopted by a three-fourths (3/4) vote of the membership present and voting.

ARTICLE IX.

Amendments

Amendments to these Articles of Incorporation may be proposed

by a majority of the membership present at any regular business meeting of the membership, and may only be adopted by a three-fourths (3/4) vote of the membership present and voting at any regular or special meeting of the membership, upon two (2) weeks notice of such meeting, stating the purpose of such meeting and, after careful consideration of all viewpoints. Upon such adoption, the same shall become effective as an amendment to the Articles upon filing with the Secretary of State of the State of Florida.

ARTICLE X.

Dissolution

No part of the net earnings of the corporation shall inure to the benefit of any donor, member, trustee or officer of the temple or any individual. No donor, member, trustee or officer of the temple or any private individual shall be entitled to share in the distribution of any of the corporation's assets. Upon dissolution, any assets of the corporation must be distributed to such religious, charitable or educational undertaking, institution or agency as a majority of the membership shall direct, provided such undertaking, institution or agency is then exempt from federal income taxes under the then existing revenue laws of the United States.

ARTICLE XI.

Resident Agent

The undersigned hereby designate SPENCER B. GILBERT, 220 South Second Street, Fort Pierce, Florida 33450, as Resident Agent of said corporation for all purposes required by law.

The congregational meeting was called to order by President Ray Isenberg. There were 60 members in attendance.

A motion was made by Shellie Rokaw, seconded by Don Lustig and passed to accept the minutes of the previous meeting.

Ray Isenberg stated that he would like to pass on the President's report and state his views as the various reports come up.

Treasurer's Report- Bernard Rubin reported that there is approximately \$143,000. in the building fund- this will be used in approximately 60 to 90 days as construction is under way. The checking account is holding a healthy balance at this time. The Yom Kippur Appeal has brought in pledges of \$14,000. and more are expected.

Pulpit Committee- Bernard Rubin reported that Rabbi Joel Dobin will be here the weekend of Oct. 10th. He will conduct the service on Friday, be taken to dinner on Saturday and if anyone wishes the Rabbi and his wife for dinner-please contact Bernard. Rabbi Dobin will be the third rabbi personally interviewed. Bernard stated that we will continue until we feel that we have the right rabbi for this community.

Membership- Ray Isenberg read the names of the new members as voted on at the last Board meeting. There are still more that will be voted on at the Oct. meeting. Ray commended and thanked Bill Sykes, Allan Rokaw and sons, Marty Skolnick & sons, Bernie Selkin, Carol Haid and all others who worked to make the High Holy Days so meaningful.

Building & Grounds- Ray expressed his appreciation to Bill Sykes for changing the Temple in a church and back again on a weekly basis. We have purchased a 12 x 20 ft. preconstructed shed that will be put on our property in the near future for storage.

Cemetery- Ray thanked Abe Grossman for a job well done and feels that the cemetery deserves a B+ for its appearance. He also extended his thanks to Sid Ribakoff for donating all the electrical fixtures needed in the cemetery.

Sisterhood- is growing rapidly. Nov. 15th a Fun and Fund Raising Dinner will be held at Peggy Berg's home.

Don Lustig and Charles Phillips will cochair the Social committee.

Bulletin- Hortie stated that she would like to have everything for the bulletin typed and put in her box in the office.

Sunshine- operates under the direction of Rose Mathis. Sid Tanner has been visiting the sick in the absence of a rabbi. Ray expressed his appreciation to Sid for doing a fine job.

Publicity- Shellie Rokaw is taking care of getting articles in the newspaper pertaining to the Temple. If anyone has anything they want put in- please contact her.

Religious School- Maxine Graber announced that Religious School will open on Oct. 4th. A letter will be sent to each parent with an application and calendar. During the year she would like to form a Religious School Committee.

A question was asked if there would be a Confirmation Class. Ray stated that he would like to see some of the members help in teaching the Hebrew and Confirmation Class.

Nursery- Helene Schweiger reported that we now have 13 children enrolled.

Building & Grounds- Ray stated that the construction has begun and will progress as quickly as possible. We have a commitment with Sun Bank for a \$160,000. mortgage at

12% for 20 years. This is a monthly payment of approximately \$1900. We will not be touching the mortgage until after our funds are exhausted.

Ray read the breakdown of cash flow from pledges and explained the minimum building fund pledge of \$500. payable over a 5 year period. Since we have had the ~~max~~ bid of \$203,000. several people have donated such things as electrical fixtures and plumbing fixtures. When asked how the shortage in pledges would be taken care of - Ray explained that many new people are joining and he is optimistic that this will take care of the payments. plus having bingo and other fund raisers when the Temple is built.

Ray explained that Rabbi Bogage has known the congregation for some time and he would be willing to come up every third week Fri., Sat. & Sun. for Religious School, Sabbath service and adult education and sick calls. He would charge \$300.00 per weekend until we secure a new rabbi. A motion was made by Susan Rifkin, seconded by Jacob Misson and passed with 3 opposed balance for us to contact Rabbi Bogage to have him come up every 3rd weekend. Bernard Rubin explained that this would in no way conflict with obtaining a new rabbi. We want to get the right rabbi for the right price.

Ray explained that the charter of incorporation of 1948 had not been reviewed until now. The charter is written so that it cannot be amended so therefore since it is outdated Spencer Gilbert has had to write up a new charter. We have been in violation of many parts of the 1948 charter and in order to take out a mortgage and become legal again a new charter is necessary.

The new document of certificate of reincorporation was read by Ray Isenberg. A motion was made by Arthur Fuss, seconded by Bernard Bereck and passed unanimously to accept the new charter of "certificate of reincorporation" as prepared by Spencer Gilbert, attorney and read by Raymond Isenberg, President.

Ray explained that the Temple is being run as a business and every member of the Board has certain duties. Helene Schweiger has been appointed the Ombudsman for the south end and Allan Bokaw for the north end so if there are any problems or if you do not understand anything- please contact one of them instead of starting any false rumors. Board meetings are open to members of the congregation so he would like to see them come to the meetings if they want to know what is happening. Policies have been established but no one has been asked to leave. He just wants all information correct before anyone passes it on.

Sol Wortman stated that a member who resigned has been making false statements and hopes that everyone realizes this instead of going along with them.

There being no further business, the meeting was adjourned.

II.

The general nature and object of this association shall be to promote, encourage and sponsor religion; to hold, own, buy, sell, lease, acquire and dispose of any and all kinds of property, real or personal, necessary or expedient in carrying out the general object of this association; to engage in benevolent and charitable objects and social work through its several members and those who may be associated with this organization; and to exercise generally all powers compatible to an organization of the character stated.

VI.

The affairs of this association shall be managed by a Board of Directors consisting of not more than nine members, the number to be determined by the By-laws of this association, which Directors are to be elected at the annual meetings of the association from the members thereof, as the By-laws shall prescribe, and vacancies in the Board of Directors, as well as vacancies in the offices of the association shall be filled in such manner as may be provided in the By-laws. All Directors and Officers elected by the Association shall hold office for one year, or until their successors shall have been elected and qualified. The President, Vice president, Secretary and Treasurer shall be elected from the members of the Board of Directors.

VII.

The names of the Directors of this association who shall serve until the first annual meeting of the members of this association, or until their successors shall have been duly elected and qualified, are:

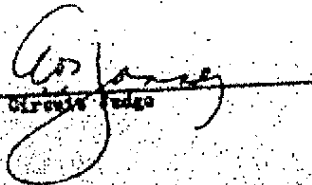
