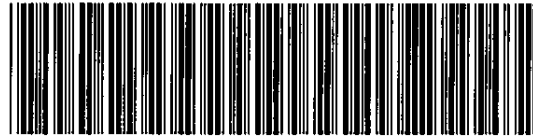



FIRST: The Articles of Incorporation of The Orange Blossom Chapter of Pancretan Association of America, Inc. were filed with the Secretary of State on the 2nd day of December, 1980, bearing document number 755355.

SECOND: The following Amendments to the Articles of Incorporation are adopted by the Corporation:

ARTICLE I

The Name of the Corporation shall be:
