



AMENDMENTS TO ARTICLES OF INCORPORATION IMMANUEL LUTHERAN CHURCH OF BRANDON, FLORIDA, INC. A CORPORATION NOT FOR PROFIT #755423

Article IX now states:

The highest amount of indebtedness or liability to which this corporation may at any time subject itself shall be the sum of One Million Dollars (\$1,000,000.00), provided any such sum of indebtedness shall not exceed in value the property of the corporation.

AMENDED ARTICLE IX shall read:

The highest amount of indebtedness or liability to which this corporation may at any time subject itself shall be the sum of Two Million Dollars (\$2,000,000.00), provided any such sum of indebtedness shall not exceed in value the property of the corporation.

<u>NOTE</u>: The congregation of Immanuel Lutheran Church voted on May 17, 1992 to increase this figure to Two Million (\$2,000,000.00). All paperwork was submitted to the state at that time but the Articles were never changed to reflect this amendment. The congregation of Immanuel Lutheran reaffirmed on November 14, 2004 their desire to uphold this amendment.

Article X now states:

This corporation may hold real estate in the value of Two Million Dollars (\$2,000,000.00) subject always to the approval of Immanuel Lutheran Church.

AMENDED ARTICLE X shall read:

This corporation may hold real estate in the value of Five Million Dollars (\$5,000,000.00) subject always to the approval of Immanuel Lutheran Church.
