

PLAN OF MERGER

OF

TOWNHOME ASSOCIATION OF OREGON STREET, INC. AND OREGON STREET TOWNHOMES ASSOCIATION, INC. INTO

OREGON STREET TOWNHOMES ASSOCIATION, INC.

This Plan of Merger is between TOWNHOME ASSOCIATION OF OREGON

STREET, INC. (the "Merged Corporation") and OREGON STREET TOWNHOMES

ASSOCIATION, INC. (the "Surviving Corporation").

RECITALS

A. The Merged Corporation is a not-for-profit homeowner's association

corporation organized and existing under the laws of the State of Florida with its principal

office at 317 Oregon Street, Hollywood, Florida 33019.

B. The Surviving Corporation is a not-for-profit homeowner's association

corporation organized and existing under the laws of the State of Florida, with its principal

office at 321 Oregon Street, Hollywood, Florida 33019.

C. The Boards of Directors of the Merged Corporation and the Surviving

Corporation have agreed that it is in their mutual best interests that the Merged

Corporation be merged into the Surviving Corporation pursuant to the provisions of the

Florida Not For Profit Corporation Act, in order to streamline operations, reduce

administrative costs and delays and obtain a uniform management of the residential

communities currently managed by the Merged Corporation and the Surviving

Corporation.

NAMES OF MERGING AND SURVIVING CORPORATIONS

TOWNHOME ASSOCIATION OF OREGON STREET, INC., the corporation

proposing to merge, shall merge into OREGON STREET TOWNHOMES ASSOCIATION.

INC., which shall be the Surviving Corporation.

TERMS AND CONDITIONS OF PROPOSED MERGER

1. The Effective Date of the merger shall be 747 to , 2005 or the date

of delivery of the Articles of Merger to the Department of State, whichever date is

permitted by law and is sooner.

2. The Board of Directors of the Merging Corporation and the Surviving

Corporation shall submit this Plan of Merger to a vote at a meeting of their members at a

special meeting on MAY 10, 2005.

3. On the Effective Date, the separate existence of the Merged Corporation

shall cease and the Surviving Corporation shall succeed to all of the powers, rights,

privileges and property of the Merged Corporation, including, but not limited to, that certain

real property commonly known as the Common Area for Oregon Street Limited

Townhomes, more particularly described in that certain Warranty Deed dated January 20,

1985 and recorded August 12, 1985 in Official Records Book 12742 at Page 645 of the

Public Records of Broward County, Florida incorporated herein by reference, without the

requirement of any additional documents of transfer. The Surviving Corporation shall be responsible for and shall assume all liabilities and obligations of the Merged Corporation.

4. The Officers and Directors of the respective corporations shall take the actions necessary to prepare, execute and file Articles of Merger with the Florida Department of State.

CHANGES IN ARTICLES OF INCORPORATION OF SURVIVING CORPORATION

There are no changes to the Articles of Incorporation of the Surviving Corporation to be effected by the merger.
