AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE CYPRESSWOOD COMMUNITY ASSOCIATION, INC.

On August 19, 2013, a meeting of the Board of Directors of The Cypresswood Community Association, Inc. ("the Association") was held, pursuant to notice duly issued. Notice of the subject matter of this amendment was included in the notice of the meeting in which this amendment was considered. A quorum was present at the meeting.

After motion duly made, seconded, and approved by at least 75 percent of the entire membership of the Board of Directors of the Association, the following amendments were made to the Articles of Incorporation of the Association, effective immediately:

Article II, Section 2.2(b) is hereby deleted and replaced with the following:

(b) To provide a system of traffic control for the members and property within Cypresswood. This system of traffic control may include one or more traffic control checkpoints, telephone, attendants, and other necessary equipment to establish an adequate system of traffic control.

After motion duly made, seconded, and approved, the Board of Directors directed the President and the Secretary of the Association to take any further action necessary to record the foregoing amendment to the Articles of Incorporation of the Association. This includes, but is not limited to, the filing of articles of amendment with the Florida Department of State and the payment of any fees associated with this.
