This Law Firm represents, Aluminum Association of Florida, Pinellas Chapter, Inc. #755699. In May 2004, Articles of Dissolution were presented for filing to your office for this Corporation which resulted in our client's corporation being "voluntarily dissolved" on the records of the Division of Corporation. A lawsuit was filed by our client against the Defendant, Aluminum Association of Florida, Inc. which sought a declaratory judgment on two issues. The second issue was to declare that the May 2004, Articles of Dissolution of my client's corporation which were filed by the executive director of the defendant organization were done without proper authority and on an invalid basis.

After a court hearing, my client obtained a Final Summary Judgment, a certified copy being enclosed, that ruled in its favor and declared the Articles of Dissolution filed with you in May to be invalid.

The purpose of this letter is to have the Secretary of State revoke, remove, cancel or do whatever is necessary to reflect that these Articles of Dissolution were not valid and to reinstate our client's corporation. I understand that it may now owe an annual fee for 2005,
