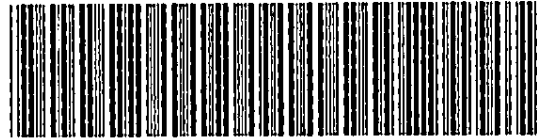

The name of the corporation is: Fort White Church Of Christ, Inc

ARTICLE II RESTATED ARTICLES

The text of the Restated Articles is as follows: ARTICLE TWO: DURATION - The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE- The Corporation is organized in order to form a church for ourselves and to do the things in our power in furtherance of our belief in Jesus Christ and His teachings. 
