Pursuant to Sections 617.1401, 1402, and 1403, Florida Statutes, this Corporation submits the following Articles of Dissolution:

FIRST: The name of the corporation is THE MOUNT HERMON COMMUNITY DEVELOPMENT ASSOCIATION, INCORPORATED.

SECOND: The Articles of Incorporation were filed on January 14, 1981.

THIRD: The Corporation commenced business on January 14, 1981.

FOURTH: No debts of the Corporation remain unpaid.

FIFTH: Adoption of Dissolution: The Corporation has no members entitled to vote.  
The dissolution was authorized by a majority of the Board of Directors on March 22, 1999.

The number of directors in office was three (3) and the vote for the resolution was unanimous.
