AMENDMENT TO THE ARTICLES OF INCORPORATION AND TO THE BY-LAWS OF 7 EAST CONDOMINIUM ASSOCIATION, INC.

TO THE ARTICLES OF INCORPORATION

ARTICLE V

1. The affairs of the Association shall be managed by a Board consisting of the number of directors as shall be determined by the By-laws or the Association, but such number shall not be less than three (3).
