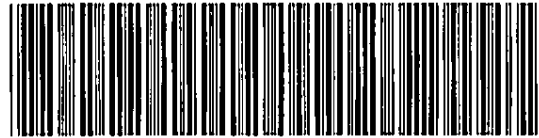



TO THE ARTICLES OF INCORPORATION

ARTICLE V
DIRECTORS

1. The affairs of the Association shall be managed by a Board consisting of the number of directors as shall be determined by the By-laws or the Association, but such number shall not be less than three (3). In the absence of a determination as to the number of members, the Board of Directors shall consist of three (3) directors. The By-laws shall provide any eligibility requirements for Directors.
