ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF HARBOUR ISLAND CLUB CONDOMINIUM ASSOCIATION, INC.

THE UNDERSIGNED, being the President and Secretary of HARBOUR ISLAND CLUB CONDOMINIUM ASSOCIATION, INC., a Florida not for profit corporation, hereby certify that, in accordance with the requirements of Florida law, and of the Articles of Incorporation of Harbour Island Club Condominium Association, Inc., at a duly called meeting of all of the unit owners of condominium units of Harbour Island Club, held on the 28th day of January, 2012, after the adoption of a Resolution by the Board of Directors, not less than a majority of the members of the Association affirmatively voted to amend the Articles of Incorporation as hereinafter set out.

NOW, THEREFORE, in consideration of the foregoing, the Articles of Incorporation shall be amended as follows:

Article VII of the Articles of Incorporation shall read:

VII. The affairs of the Corporation shall be managed by the President of the Corporation, assisted by the Vice Presidents, if any, Secretary and Treasurer, the Assistant Secretaries and Assistant Treasurers, if any, subject to the directions of the Board of Directors.
