**CERTIFICATE OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
WILLIAMSBURG VILLAS HOMEOWNERS ASSOCIATION, INC.**

**A Not For Profit Corporation, Incorporated Florida, 1978**

A Corporation Not-For-Profit Under  
the Laws of the State of Florida

The Articles of Incorporation of Williamsburg Villas Homeowners Association, Inc. were filed with the Florida Secretary of State on December 31, 1981. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 527, Page 2059, et. seq. The same Articles of Incorporation are hereby amended as adopted by the entire membership by unanimous written consent.

1. Article I is amended to read as follows:

**ARTICLE 1  
Name and Definitions**

The name of the corporation shall be WILLIAMSBURG VILLAS CONDOMINIUM ASSOCIATION, INC. For convenience the corporation shall be referred to in this instrument as the Association, the Articles of Incorporation as Articles, and the Bylaws of the Association as Bylaws.

(The balance of Article I remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of Williamsburg Villas Homeowners Association, Inc. was adopted by the entire membership by unanimous written consent.
3. All provisions of the Articles of Incorporation of Williamsburg Villas Homeowners Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
