ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

of

TAMIAMI VILLAGE HOMEOWNERS ASSOCIATION, INC.

Document Number: 756896

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida not for profit corporation adopts the following articles of amendment to its Articles of Incorporation.

ARTICLE I

RECITALS

- 1.1 Whereas the complete history of the Corporation is unknown at this time, the Directors, Officers and Members of the Corporation wish to clarify the present Authority, Power and Purpose of the Corporation.
- 1.2 The Corporation was created or established by the Declaration, registered in Lee County, Florida, as a governing document for the Subdivision Section in Tamiami Village, on September 30, 1977.
- 1.3 Paragraph 7 of the said Declaration states: "All owners of lots in the Property shall automatically become members of Tamami Village Homeowners Association, Inc., a Florida non-profit corporation, and shall be liable for property charges imposed by such corporation."
- 1.4 Presently, the Directors are unaware of the Corporation ever being registered with the State of Florida at the time of the recording of the Declaration in Lee County.
- 1.5 A corporation known as TAMIAMI VILLAGE LOT OWNERS ASSOCIATION INC. was registered with the State of Florida on March 23, 1981; and thereafter filed an Articles of Amendment to change its name to TAMAMI VILLAGE HOMEOWNERS ASSOCIATION INC. on March 26, 2002.
- 1.6 While the Corporation established its existence, powers and purpose under Chapter 617, before Chapter 720 was enacted into law in the year 2000, section 617,0301 now states: "...if special provisions are made, by law, for the organization of designated classes of corporations not for profit, such corporations shall be formed under such powers and not under this act."
- 1.7 The Directors, Officers and Members of the Corporation therefore find it necessary and compelling to clarify its Authority, Power and Purpose by these Amended Articles of Incorporation, so as to be in accordance with Chapter 720.

ARTICLE II

<u>AUTHORITY</u>

- 2.1 The Corporation is created pursuant to the Declaration of Conditions, Covenants, Charges, Restrictions and Reservations (CCR) affecting property located in Tamiami Village as set forth on a certain plot recorded in Condominium Plat Book 3 at pages 60-67 inclusive of the Public Records of Lee County Florida.
- 2.2 The Corporation is organized pursuant to Title XL, Real and Personal Property Law of the State of Florida, Chapter 720 and is intended to exercise all rights and responsibilities of a Homeowners Association as set forth therein.

ARTICLE III

POWERS

3.1 The Corporation shall have all of the powers delegated to Homeowners Associations by said Chapter 720 of the Florida Real and Personal Property Law, together with such other powers as necessary and incidental to the exercise of the aforesaid Homeowners Associations; and the power to carry out any other lawful purpose.

ARTICLE IV

PURPOSE

4.1 The purpose of the Corporation is to operate the Subdivision as a not-for-profit residential community in the State of Florida as a Homeowners Association (HOA), while promoting a safe, stable and economically secure environment for its residents and to protect and preserve the residents' rights as property owners.

ARTICLE V

JURISDICTION

5.1 The real and personal property that this Corporation has jurisdiction over and to which its rights and responsibilities apply is all that land depicted as lots and common areas on a certain plat recorded in Condominium Plat Book 3 at pages 60-67 inclusive, of the Public Records of Lee County Florida.

ARTICLE VI

ORGANIZATION

6.1 The Corporation shall operate under the direction of a seven (7) member Board of Directors, elected by the members of the Association in accordance with its by-laws.

ARTICLE VII

<u>MEMBERS</u>

Pursuant to the Declaration (CCR) referred to above, every owner of a residential lot in the Subdivision, shall automatically become a member of the said HOA and shall be entitled to one (1) vote for each residential lot owned, all in accordance with the by-laws of the Corporation.

ARTICLE VIII

PRINCIPAL ADDRESS OF CORPORATION

The principal office and address of the Corporation is 9210 Bonita Drive, North Fort Myers, Florida 33903. The Board of Directors may from time to time move the principal office to any other address.

ARTICLE IX REGISTERED AGENT

ARTICLE X OFFICERS AND DIRECTORS
