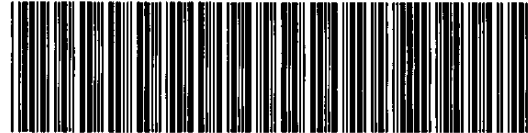

The following Amendment to the Articles of Incorporation of Archdiocese of Miami Education Endowment Fund, Inc., a Florida not for profit corporation, duly adopted pursuant to the authority of Section 617.1002 of the Florida Statutes, and the existing Articles of Incorporation and Bylaws of Archdiocese of Miami Education Endowment Fund, Inc., a Florida not for profit corporation, wherein, after proper notice and upon proposed Resolution adopted by a majority of the Directors, a majority of the Members adopted said amendment at a duly called and constituted meeting with the consent of The Most Reverend John C. Favalora; as Archbishop of the Archdiocese of Miami, his successors in office, a corporation sole, and that a majority vote of the Members is all that is required for such amendment. This amendment supersedes and takes the place of such original provision of the Articles of Incorporation and any amendments thereto which were filed with the Secretary of State on February 27, 1981, March 27, 1982 and October 28, 1992.

BE IT RESOLVED, that the Articles of Incorporation of Archdiocese of Miami Education Endowment Fund, Inc., a Florida not for profit corporation, be and the same are hereby amended to read as follows:

ARTICLE I, is amended to read as follows:

ARTICLE I

- A) The name of the corporation shall be: Archdiocese of Miami Endowment Fund, Inc.
- B) The existence of the corporation shall be perpetual.
- C) The principal office of the corporation will be located at 9401 Biscayne Boulevard, Miami Shores, FL 33138.
- D) The resident agent of the corporation is J. Patrick Fitzgerald, whose address is 110 Merrick Way, Suite 3-B, Coral Gables, FL 33134.



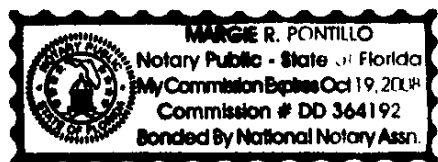
