

ARTICLE VIII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors consisting of the number of Directors set forth in the Bylaws nine-(9) persons, each of whom shall be members of the Association or the spouse or live-in companion of a member of the Association.

ARTICLE XIII OFFICERS

The Board of Directors shall elect the President, Secretary, Treasurer, and as many Vice-Presidents, Assistant Secretaries, and Assistant Treasurers and/or other officers as the Board of Directors shall from time to time determined.
