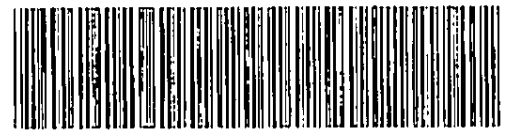

ARTICLES OF AMENDMENT:

The Urban League Housing Corporation of Greater Miami, Inc.

A Florida Not for Profit Corporation - Document Number: 757186

Pursuant to the provisions of sections 617.1002 and 617.1006, Florida Statutes, the undersigned Florida not for profit corporation ("Corporation") adopts the following articles of amendment to its certificate of incorporation.

**Manner of Adoption:**

There are no members entitled to vote on the amendments.

On October 20, 2017, 2017, at a regular meeting with a quorum present, these Articles of Amendment were adopted by the board of directors of this Corporation. That meeting met the requirements of the Certificate of Incorporation and bylaws.

**The Amendment:**

Article II(a) of the Certificate of Incorporation is hereby amended and replaced in its entirety. The new Article II(a) reads in its entirety as follows:

(a) The exclusive purpose of this Corporation is to engage in charitable activities that qualify as exempt under of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code. Included within that purpose is to provide elderly and handicapped persons with housing facilities and services especially designed to meet their physical, social, and psychological needs, and to promote their health, security, happiness and usefulness in longer living, the charges for such facilities and services to be predicated upon the provision, maintenance and operation thereof on a non-profit basis. Also included with that purpose is to foster low-income housing.
