AMENDED ARTICLES OF INCORPORATION

OF

GERMAN—AMERICAN CLUB OF ST. AUGUSTINE, INC. Document Number 757526

WHEREAS, we the undersigned hereby associate ourselves for the purpose of amending the Articles of Incorporation of German-American Club of St. Augustine. Inc. by submitting these amended articles of incorporation, pursuant to a majority vote of the membership of the corporation on May 31, 2019.

ARTICLE I. NAME

The name of this corporation shall be GERMAN-AMERICAN CLUB OF ST. AUGUSTINE, INC., and is to be located in St. Augustine, St. Johns County, Florida.

ARTICLE II. PRINCIPAL OFFICE

The principal office of the corporation shall_be located at 1985 State Road 16, St. Augustine, FL 32095.

ARTICLE III. PURPOSE

To promote, foster and develop good relations with families of German heritage and to promote, stimulate and develop any project which the corporation deems to be in the best interest and welfare of its membership and of the people of St. Augustine and St. Johns County, Florida. To buy, sell, own, hold and operate real and personal property of all kinds necessary or incident to the within purposes; to own, buy, sell, mortgage and encumber in any manner, lease and improve real estate and personal property for itself and others, and to engage in any other activities permitted by law.

ARTICLE IV. USE OF INCOME

All revenue, profit, income and money received from the conduct of the corporation's activities is to be used for the benefit of the membership or the community, as the members of the German-American Club of St. Augustine may see fit.

ARTICLE V. REGISTERED AGENT AND ADDRESS

The following is the designation of Registered Office and Agent of the corporation Not for Profit, and the undersigned accepts said designation as Agent:

ARTICLE VI. TERM OF EXISTENCE

This corporation shall have perpetual existence until such time as it is dissolved according to law.

ARTICLE VII. MEMBERSHIP

This Corporation shall consist of at least one or more natural persons, who shall be known as members, membership being available to any natural person who is a resident of St. Johns County, Florida, with the exception that any person who was a member of the club as of March 1, 2019, shall continue to qualify for membership regardless of where they reside.

After March 1, 2019, new members shall be admitted only by written application approved by a majority vote of the Board of Directors which vote shall constitute approval of the membership application by the Board of Directors. No member shall receive any payment or other compensation for service in connection with the administration or affairs or activities of the corporation, but may be reimbursed for actual expenses incurred after the same have been authorized by the Board of Directors. Each member shall have one vote.

ARTICLE VIII. SHARES

The corporation shall be authorized to issue a total of TWO THOUSAND (2,000) shares of stock. Each member of the club shall be issued one share of stock for each year of their membership as of March 1, 2019, and for each full year of membership in good standing thereafter.

ARTICLE IX. OFFICERS AND DIRECTORS

The Board of Directors of the corporation shall consist of no more than five (5) directors who shall be designated as board members and who may serve as officers of the corporation. In addition there shall be three (3) board members-elect who shall succeed any of the five sitting directors as needed. The Board of Directors shall manage the affairs of this Corporation, and they will be elected annually at the annual meeting held in June. The By-Laws of the Corporation are to be made, altered or rescinded by the members of the Board of Directors, subject to the approval of a majority of the membership at a regular meeting.

ARTICLE XI. INDEBTEDNESS

There shall be no limitation upon the amount of indebtedness that this Corporation may incur.

ARTICLE XII. MEETINGS

The membership of this Corporation must meet at least quarterly. However, meetings may be more frequent at the discretion of a majority of the Board of Directors accompanied by written notice to the membership. It shall be permissible to address club or corporation business and hold votes of the general membership at any club event where all members are invited to attend.

ARTICLE XIII. AMENDMENT

These Articles of Incorporation may be amended by amendment proposed at any meeting of the membership and approved by a two-thirds (2/3) vote of said membership present at the meeting.

ARTICLE XIV. DATE OF ADOPTION/EFFECTIVE DATE

These Amended Articles of Incorporation were adopted by a vote of the shareholders sufficient for approval on May 31, 2019, and shall be effective as of that date.
