The following are amendments to the Articles of Incorporation of Viewpoint Condominium Association, Inc., originally recorded at Official Records Book 5238, Page 256, et. seq. Public Records of Pinellas County, Florida, and as subsequently amended.

New Wording <u>Double-Underlined</u>; Deleted Wording <u>Stricken-Through</u> (Except when proposed amendment involves substantial rewording).

Articles of Incorporation Section 10 is amended to read as follows:

10. BY-LAWS

The By-Laws of the Association shall be adopted by the Board of Directors and may be altered, amended or rescinded as provided in the Bylaws. in the following manner:

- (a)—approval—of—seventy-five(75%)—percent—of—the—entire membership of the board of Directors and of-fifty one (51%) of the votes of the entire membership of the Association; or
- (b) approval of seventy five (75%) percent of the votes of the entire membership of the Association; or
- (c)—approval—of—all—of—the—directors,—as—long—as—the—original directors named in these Articles of Incorporation remain in office.
