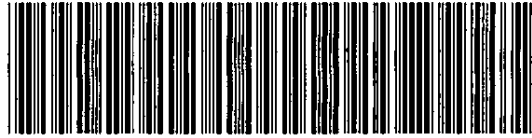


To Whom It May Concern:

Our law firm serves as the Office of the City Attorney for the City of Pembroke Pines, Florida. During the 2008-2009 fiscal year, the City budget for and contributed funds to the operation of the Citizens Crime Watch of Pembroke Pines, Inc. ("Crime Watch"). Crime Watch was an entity separate and distinct from the City of Pembroke Pines. However, the City permitted Crime Watch to use office space at a City building for its operations. Accordingly, Crime Watch registered its business address with the State Division of Corporations as 501 NW 103rd Avenue, Pembroke Pines, FL, 33026.

Crime Watch is now a dissolved corporation and no longer has an office at the above-referenced City of Pembroke Pines municipal address. Pursuant to the attached Dissolution documents, which I obtained from your web site, Crime Watch President Rudy Tamayo provided your office with a new mailing address: Rudy Tamayo, Crime Watch, 4387 Vintage Hills Drive, Bryan, TX, 77808.
