

## Amended and Restated Articles of Incorporation

OF

#### OAK TREE ESTATES HOMEOWNERS' ASSOCIATION, INC.

(A Corporation Not for Profit Under the Laws of the State of Florida)

The undersigned hereby associate themselves for the purpose of becoming incorporated under the laws of the State of Florida applicable for corporations not for profit, under the following proposed charter:

### ARTICLE I. NAME

The name of this corporation shall be Oak Tree Estates Homeowners' Association, Inc., and it shall be located at 2744 Oak Tree Lane, Fort Lauderdale, Broward County, Florida.

#### ARTICLE II. PURPOSE

The Association is organized for the following purposes:

- (a) to promote the beauty, well-being, economic stability, safety, and desirability of the residential neighborhood in which the members of this corporation live and to do anything or matter consistent with law to accomplish such purpose.
- (b) to promote and encourage a community spirit among its members and to manage and promote social, recreational and maintenance functions for the benefit of all the members of the Association.
- (c) to exercise all lawful powers consistent with the foregoing and necessary to the management and maintenance of the private roads, pavements, streetlights, other amenities, common areas and facilities and aesthetic beauty of the Oak Tree Estates, located in Oakland Park, Broward County, Florida.
- (d) to exercise all powers permitted by law to a non-profit corporation.

#### ARTICLE III. MEMBERSHIP

The members of the association shall consist of all the record owners of lots, improved or unimproved, within the following described geographical bounds within Broward County, Florida:

All that part of the Southwest one-quarter (SW ¼) and the Southeast one-quarter (SE ¼) of Section 17, Township 49 South, Range 42 east, Broward County, Florida, more particularly described as follows:

Beginning at the Northwest (NW) corner of the southeast one-quarter (SE ½) of the Southwest one-quarter (SW ½) of said Section 17, then N 88\*22'14" 140.00 feet; thence N01\*36'51"W along a Line 140.00 feet East of and Parallel with the West Line of the East one-half (E ½) of the said SW ¼ 526.06 feet; thence N 88\*14'05" E, 80.00 feet; thence N 01\*45'55" W, 10.00 feet; thence N 88\*14'05" E, 100.00 feet; thence N 01\*45'55" W, 80.0 feet; thence N 88\*14'05" E, 376.78 feet to a Point of Curvature, thence southeasterly along the arc of a circular curve to the right, having a radius of 200.00 feet, and arc distance 130.21 feet to a point of reverse curvature; thence Southeasterly along the arc of a reverse curvature; thence Southeasterly along the arc of circular curve to the left, having a radius of 240.00 feet, an arc distance of 98.72 feet, thence S 39\*43'54" E, 30.99 feet, thence S 01\*25'56" E, 63.23 to a Point of Curvature; thence Southerly and Westerly along the arc of a circular curve to the right, having a radius of 120.00 feet; an arc distance of 198.33 feet; thence S 86\*44'06" W, 142.47 feet; thence N73\*40'59" W, 82.00 feet; thence S 07\*07'21" W, 157.92 feet; thence S 03\*15'54" W, 40.00 feet; thence N 86\*44'06"W, 10.00 feet; thence N73\*40'59" W,

82.00 feet; thence S07\*07'21" W, 157.92 feet; thence S15\*27'06" E, 148.75 feet; thence S 86\*44'06 E, 153.98 feet; thence N11\*39'07" E, 282.95 feet; thence Northeasterly along the arc of a circular curve to the left having a radius of 160.00 feet, and arc distance of 173.79 feet; thence S01\*25'56" E, along a line 462.00 feet West of and parallel with the East Line of the SW 1/4 of said Section 17, 360.93 feet to a Point on the South line of the NE ¼ of the SW ¼ of said Section 17; thence N 88\*22'14" E, along the said South Line of the NW ¼ of the SE ¼, 695.09 feet; thence N 32\*09'53" E, 460.00 feet; thence N 57\*50'07" W 100.00 feet, thence N32\*09'53" E, 98.574 feet to a Point of Curvature; thence Northerly along the arc of a circular curve to the left, having a radius of 100.00 feet, and arc distance of 59.23 feet, thence N 01\*46'32" W, 39.392 feet to a Point of Curvature, thence Northeasterly along the arc of a circular curve to the right, having a radius of 25.00 feet, an arc distance of 39.27 feet; thence S 88\*13'28" W, 75.00 feet; thence N 01\*46'32" W, 30.00 feet to a Point of the North Line of the S ½ of the N ½ of the SE ¼ of said Section 17; thence S 88\*13'28" W, along the said North Line of the S ½ of the N  $\frac{1}{2}$  of SE  $\frac{1}{4}$ , 425.03 feet to the Northeast corner of the S  $\frac{1}{2}$  of the NE  $\frac{1}{4}$  of the SW 1/4, the same being the SW corner of Parcel "L" TAMARAC LAKES SOUTH, recorded in Plat Book 62, page 24, of the Public Records of Broward County, Florida;

Thence S 88\*14'05" W, along the North Line of the S ½ of the NE ¼ of the SW ¼ said Section 17, and the South Line of TAMARAC LAKES SOUTH, 1343.06 feet to the Northwest corner of the S ½ of the NE ¼ of the SW ¼, thence S 01\*36'51" E, along the West Line of the said S ½ of the NE ¼ of the SW ¼ and the East Boundary of the said TAMARAC LAKES SOUTH, 665.79 feet to the Point of Beginning. Said lands situate, lying and beginning in Broward County, Florida.

It shall be the sole responsibility of the membership of the Association to pay all costs of maintenance and to properly maintain all private streets and pavements, the storm drainage system, the sanitation sewer gravity collection system, the pump station and force main and other common areas or elements, to include the entry road into the Subdivision from Prospect Road and to include replacement of such items determined to be necessary in accordance with the procedures provided for in these Articles and the ByLaws.

### ARTICLE IV. Terms of Existence

The term of existence of this corporation shall be perpetual.

### ARTICLE VI. FIRST BOARD OF DIRECTORS AND OFFICERS

The subscribers aforestated shall consist of the First Board of Directors and Officers of the corporation under these Amended Articles. There shall be four (4) officers: President, Vice President, Secretary, and Treasurer each of whom shall be a member of the Board of Directors in order to qualify for officership. There shall be a minimum of five (5) directors. Each director shall be elected by the general membership at the annual meeting and shall serve for until the next annual meeting of the members and thereafter until his successor is duly elected and qualified or until he is removed in the manner provided in the ByLaws. The officers shall be elected after each annual meeting by the then Board of Directors.

All legal instruments of the corporation shall be signed by the President or Vice-President and attested by the Secretary. The full Board of Directors shall make reports of the receipts and disbursements, and balances of the assets of the corporation, and the affairs of the corporation at the annual meeting of the corporation or more frequently as may be required by law, and, when so required, shall make such reports to any other duly constituted business meeting of the corporation.

Directors shall be elected by the membership, attending in person or by proxy, at the annual meeting pursuant to the voting procedure set forth in the ByLaws. The Directors shall manage the affairs of the corporation except as otherwise set forth in the Articles or ByLaws.

### ARTICLE VII. BYLAWS

The ByLaws may be altered, amended or rescinded in the manner provided by the ByLaws as well as by a majority vote of the members of this corporation present at any duly constituted annual meeting of the corporation.

### ARTICLE VIII. POWERS OF THE MEMBERSHIP

The membership shall have the power to elect Directors at the annual members meeting and shall have such other powers as may be provided in these Articles, the ByLaws, the Protective Covenants or ByLaws.
