

EXHIBIT "A"

AMENDMENT* TO ARTICLES OF INCORPORATION

1. Article VIII of the Articles of Incorporation shall be amended to read as follows:

ARTICLE VIII

The affairs of the Corporation shall be governed by a Board of Directors which Board will consist of <u>not less than five (5) nor more than</u> seven (7) persons. Directors shall be elected from among the Unit Owners; or if a Unit Owner shall be a corporation, partnership or trust, then an Officer, partner or beneficiary of such Unit Owner shall be qualified to be a Director. The Board of Directors shall have all the powers and duties necessary for the administration of the affairs of the Corporation and shall have all the powers and duties referred to in the Declaration and in the Statutes of the State of Florida respecting corporations not-for-profit, and all of the powers defined and set forth in the Condominium Act of the State of Florida which the Unit Owners collectively may do or may have done. The powers of the Board of Directors shall be as set forth in the Bylaws of the Corporation.
