AMENDMENTS TO THE ARTICLES OF INCORPORATION OF THE CORINTHIANS SOUTH CONDOMINIUM ASSOCIATION, INC.

Article XII(E) of the Articles of Incorporation of The Corinthians South Condominium Association, Inc., shall be deleted in its entirety:

Notwithstanding the foregoing provision of this Article XII, there shall be no amendment to these Articles which shall abridge, amend or alter the rights of Developer, including the right to designate and select the Directors as provided in Article IX hereof, without the prior written consent therefor by Developer nor shall there be any amendment to these Articles which shall abridge, alter or modify the rights of any "Approved Mortgagee" (as that term is defined in the Declaration).
