Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST: ARTICLE I – IS AMENDED AS FOLLOWS:**

The name of the Corporation is **CHURCH OF GOD, SOURCE OF VICTORY, AND HOUSE OF PRAYER, INC.**

**THIRD: ARTICLE VI – IS AMENDED AS FOLLOWS:**

Section 1. The affairs of the Corporation shall be managed by a Board of Directors. The Board of Directors shall consist of not less than three (3) and not more than five (5) persons. Directors shall be elected or removed at the annual meeting of the congregation, which shall be one year from the date of these Articles of Incorporation and in accordance with the procedure provided by the Bylaws.

Section 2. The officers of the Corporation shall be a Pastor, an Assistant Pastor, Treasurer, Chairman, Assistant Treasurer and Secretary. These officers shall be elected at the


