



CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

LONG BAY PLANTATION ASSOCIATION, INC.

n/k/a

THE ESTUARY AT NORTH RIVER SHORES CONDOMINIUM ASSOCIATION, INC.

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of Long Bay Plantation Association, Inc. n/k/a The Estuary at North River Shores Condominium Association, Inc. were filed with the Florida Secretary of State on August 11, 1981, and an amendment filed on January 10, 1997. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 547, Page 42, et. seq. and amended at OR Book 720, Page 184, et. seq., and OR Book 1208, Page 468, et. seq. The same Articles of Incorporation are hereby amended as adopted by at least sixty percent (60%) of the Board of Directors at their meeting held on January 18, 2011 and by at least fifty-one percent (51%) of the votes of the entire membership, which vote was sufficient for approval, at the Members Meeting held on April 19, 2011.

- 1. Article 9.2 is amended to read as follows:
- 9.2 <u>Adoption</u>. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. The approvals must be either:
- a. By not less than 60% of the entire membership of the Board of Directors and by not less than two-thirds (2/3) of the members present and voting in person or by proxy at a duly convened meeting of the members; or
- b. By not less than 60% of the votes of the entire membership of the Association.


(The balance of Article 9 remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of Long Bay Plantation Association, Inc. n/k/a The Estuary at North River Shores Condominium Association, Inc. was adopted by at least sixty percent (60%) of the Board of Directors at their meeting held on January 18, 2011 and by at least fifty-one percent (51%) of the votes of the entire membership, which vote was sufficient for approval, at the Members Meeting held on April 19, 2011.

- 3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation of Long Bay Plantation Association, Inc. n/k/a The Estuary at North River Shores Condominium Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.


