Dear Greg:

This is in reference to the tax-exempt status of the Orlando Young American Bowling Alliance. Our records indicate that the Orlando YABA is currently exempt from federal income taxes under a group exemption granted by the IRS under Section 501(c)(3) of the Internal Revenue Code. The association Employer Identification Number is 59-1858997.

The Young American Bowling Alliance has been granted from the IRS a tax exemption for all local and state associations under Section 501(c)(3) of the Internal Revenue Service Code in 1999. By approving this exemption, the IRS gave permission to associations to qualify for tax-exempt status as amateur sports organizations.

As stated in the YABA local and state association bylaws, "the association is operated exclusively for charitable and educational purposes, and particularly to foster regional, national and international bowling competition either directly or by contributions to organizations that are recognized as exempt from federal income taxation as organizations described in section 501(c)(3). The association is also organized and operated primarily to conduct or support bowling competition and support and develop amateur bowling athletes for national competition within the meaning of I.R.C. Section 501(j)(2) of the Internal Revenue Code of 1986".

As of September 18, 1999, all local and state associations listed as a 501(c)(4) organizations under the YABA tax-exempt group were re-classified as 501(c)(3) organizations. The GEN is 3520 for all YABA subsidiaries.
