ARTICLES OF AMENDMENT

SECOND AMENDMENT TO ARTICLES OF INCORPORATION OF THE MOORINGS OF PERDIDO KEY, INC.

Pursuant to Article IX of the First Amendment to Articles of Incorporation of The Moorings of Perdido Key, Inc., the undersigned Florida non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.
