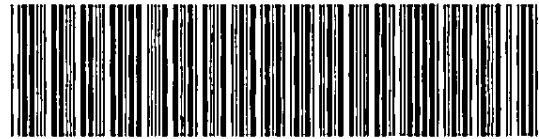

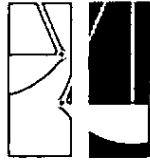

**PLAN OF DISTRIBUTION OF ASSETS
OF
VOICE FOR JESUS**

(A Florida Not For Profit Corporation)

The Board of Trustees of Voice For Jesus, a Florida not for profit corporation (the Corporation), at a special meeting duly convened on the 30th day of March, 2021, pursuant to notice given in accordance with the applicable law, a quorum being present at all times (or by unanimous written consent) resolved to dissolve the Corporation and adopted by a majority vote the following plan of distribution of assets:

1. All substantiated liabilities and obligations of the Corporation shall be paid and discharged (or the Corporation has no liabilities) including the following:

a. \$408.25 shall be paid to Haimo Law in order to satisfy the outstanding balance from its invoice #1518 for legal services rendered on behalf of the Corporation to effectuate the dissolution of the Corporation.

b. \$2,500.00 shall be paid to Christopher Cochran as compensation in his capacity as appointed representative in order to effectuate the dissolution of the Corporation.

c. A reasonable reserve in the amount of Fifty Thousand Dollars (\$50,000.00) shall be held in the Haimo Law Trust Account for a reasonable time to ensure any unidentified outstanding claims or liabilities may be appropriately satisfied.

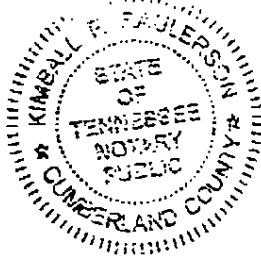
2. Any assets that were temporarily held by the Corporation upon the agreement that the assets are to be returned upon dissolution have previously been returned, transferred, or conveyed in accordance with such agreement.

3. All other assets shall be transferred or conveyed to domestic organizations engaged in activities substantially similar to those of the Corporation pursuant to Section 617.1406, Florida Statutes.
