ARTICLES OF MERGER BETWEEN BIG BROTHERS/BIG SISTERS OF TAMPA BAY, INC. AND BIG BROTHERS/BIG SISTERS OF POLK COUNTY, INC.

Pursuant to Section 617.1105 of the Florida Not for Profit Corporation Act, Big Brothers/Big Sisters of Polk County, Inc. ("Polk"), and Big Brothers/Big Sisters of Tampa Bay, Inc. ("Survivor") adopt the following Articles of Merger for the purpose of merging Polk into the Survivor, the latter of which is to survive the merger.

ARTICLE I

The Plan of Merger is as follows:

PLAN OF MERGER

Big Brothers/Big Sisters of Polk County, Inc., a Florida corporation ("Polk"), and Big Brothers/Big Sisters of Tampa Bay, Inc., a Florida corporation (the "Survivor"), hereby adopt the following plan of merger pursuant to Section 617.1101, Florida Statutes.

a)	The names of each corporation planning to merge are:	971 SEC

b)	The Survivor is the surviving corporation and its name is:	ED PM12: OF STA E, FLOR
	Big Brothers/Big Sisters of Tampa Bay, Inc.	2 H 2

c) The terms and conditions of merger are as follows:

On the effective date of the merger, the separate existence of Polk shall cease and the Survivor shall succeed to all the rights, privileges, immunities, and franchises and all the property, real, personal and mixed of Polk without the necessity for any separate transfer. The Survivor shall thereafter be responsible and liable for all obligations of Polk, and neither the rights of the creditors nor any liens on the property of Polk shall be impaired by the merger. The Survivor shall succeed to and be the beneficiary of all grants, bequest, devises, trusts, or inheritances heretofore made or hereinafter made in favor of or for the benefit of Polk.

d) There will be no changes in the Articles of Incorporation or Bylaws of the

Survivor, and the Articles of Incorporation and Bylaws of the Survivor as they exist on the effective date of the Merger shall continue to be the Articles of Incorporation and Bylaws of the Survivor.

ARTICLE II

The effective date of the merger shall be effective December 31, 1996.

ARTICLE III

Polk adopted the Plan of Merger effective December 31, 1996, by vote of a majority of the Board of Directors of Polk pursuant to Section 617.1103(2), Florida Statutes. The Survivor adopted the Plan of Merger effective December 31, 1996, by vote of a majority of the Board of Directors pursuant to Section 617.1103(7), Florida Statutes. These votes constitute a sufficient number of votes of both corporations to approve the merger. Neither Polk nor the Survivor has any members entitled to vote on the Plan of Merger.

ARTICLE IV

In the event that there is a dissolution of the merger and Big Brothers/Big Sisters of Tampa Bay, Inc., ceases to serve Polk County, then the Tampa Bay Agency agrees that the Polk County Agency will retain possession of the real property described in attached A and its related facility will be transferred to a duly authorized Big Brothers/Big Sisters Agency serving Polk County, Florida, as long as the agency is duly authorized and chartered by the national Big Brothers/Big Sisters authorization.
