## CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE BARCLAY BEACH CLUB CONDOMINIUM ASSOCIATION I, IN

THE BANGEAT BEAGT GLOB COMBONIATION FROM THE

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of The Barclay Beach Club Condominium Association I, Inc. were filed with the Florida Secretary of State on September 11, 1981. The same Articles of Incorporation were recorded in Official Records of St. Lucie County, Florida at Official Records Book 472, Page 625, et. seq., and amended at OR Book 472, Page 636, et. seq., OR Book 472, Page 640, et. seq., OR Book 810, Page 2309, et. seq., and amended and restated at OR Book 811, Page 1842, et. seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at a Members Meeting held on May 31, 2006.

1. Article IV is amended to read as follows:

### **ARTICLE IV**

## Members

4.1 The members of the Association shall consist of all of the record owners of units in the condominium <u>and their lawful spouses</u>, and after termination of the condominium shall consist of those who are members at the time of such termination and their successors and assigns.

(The balance of Article IV remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of The Barclay Beach Club Condominium Association I, Inc. was adopted by the membership by a vote sufficient for approval at a Members Meeting held on May 31, 2006.
- 3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation of The Barclay Beach Club Condominium Association I, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
