**WHEREAS**, pursuant to Article X of the Articles of Incorporation, the Articles of Incorporation may be amended upon the affirmative vote of not less than a majority of the Association's Board of Directors or by unit owners representing not less than a majority of the units at a duly called meeting at which a quorum is present;

**NOW, THEREFORE**, Darlene Vatikiotis, as President and Paula Littlefield, as Secretary of Villa Plumosa Condominium Association, Inc. do hereby certify that the following amendment to the Articles of Incorporation of Villa Plumosa Condominium Association, Inc. was approved by the affirmative vote of the unit owners representing not less than a majority of the units at the special membership meeting held on March 22, 2017, at which a quorum was attained:

**I. Article V, Section 1 of the Articles of Incorporation of Villa Plumosa Condominium Association, Inc. is hereby amended to read as follows:**

Section 1. The affairs of the Association will be managed by a board consisting of the number of directors determined by the By-Laws, but not less than three (3) directors. Directors ~~need~~ must be members of the Association.
