CONSTITUTION OF SUNCOAST DANCE & PARTY CENTER, INC.

ARTICLES OF INCORPORATION (A CORPORATION NOT FOR PROFIT)

We, the members of **Suncoast Dance & Party Center**, **Inc.**, associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, do hereby adopt the following articles of incorporation:

ARTICLE I: NAME

The name of the corporation shall be: SUNCOAST DANCE & PARTY CENTER, INC.

ARTICLE II: DURATION

The terms of existence of the corporation are perpetual.

ARTICLE III: PURPOSE

The corporation is organized in order to engage in any lawful purpose not for profit.

ARTICLE IV: DIRECTORS

There shall be 16 members of the Board of Directors of the Corporation.

ARTICLE V: DIRECTORS

The officers of the Corporation are to be managed by a President, Sergeant at Arms, Auditors and Directors. Such officers will be elected annually by the Board of Directors. The By-laws of the Corporation are to be made, altered or rescinded by the Directors, of the Corporation and recommended to the members for change.
