Please find enclosed Document # 760800 (Application for Reinstatement) that was completed on October 24, 2002. All of the officers and directors have been changed to the new slate of officers and directors that became effective recently.

The previous slate of officers and directors are from the 2001 season. The officers and directors for the 2002 season where not change due to the fact that our officers and directors are not named until the end of each May. The miss-match of the filing due date and the election of new officers and directors cause problems.

This year the new slate of officers and directors did not take place until October 5, 2002. Our post office box was closed back in June or July due to non-payment and was not re-open until October 8, 2002.
