ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 617.1403 of the Florida Not for Profit Corporation Act (the "Act"), Florida Rock Industries Foundation, Inc., a Florida not for profit corporation, does hereby execute and adopt these Articles of Dissolution and states as follows:

1. The name of the corporation is Florida Rock Industries Foundation, Inc.
2. The corporation has members entitled to vote on the dissolution of the corporation. The said members, acting by written consent pursuant to Section 617.0701 of the Act, unanimously adopted a resolution approving the dissolution by executing that certain Joint Unanimous Written Consent of the Members and Directors of Florida Rock Industries, Inc. dated February 29, 2008.
