Minutes: Motion to accept minutes of previous meeting.  
Passed.

Steve Meisel: Reported a balance of \$10,483.40 in checking  
(Treasurer) account and \$538.73 in savings.

Kevin Meisel: Reported on years activities. Kevin and Harry  
(Vice-Pres.) attended ASCA "World Clinic" in New Orleans on  
Sept. 6-10. They were featured on cover of ASCA  
magazine (July/Aug) as outstanding "grass roots"  
coaches and their Wash., D.C. lecture, "TRICKS  
OF THE TRADE" was reprinted. 1995 was another  
outstanding year as the team placed 4th at JOSC  
and 5th at JOLC. 10 & Under girls Med. Relay  
team broke State record at LC and Brooke Taylor  
set a new 50 Fly record. After a very successful  
Poinsettia fund raiser, in late November, new  
items of training equipment were purchased for  
branch pools. The Poinsettia incentive program  
saw many swimmers receiving parkas, team bags  
and jackets. Suggested that next year two from  
main branch visit other branches to explain the  
program for greater swimmer/parent support.

Harry Meisel: Noted that membership dropped due to 210 swimmers,  
(Pres.) due to several families moving out of town and  
others affiliating with clubs closer to home  
due to transportation and ever increasing traffic  
in the area. As a possible solution a form will  
be sent out for a school listing, so that parents  
can car pool. In an effort to recruit new swimmers  
500 brochures were distributed at Park Maitland  
School. "Bring-A-Buddy" days will be held at  
all branches in the Spring. We will continue  
Sat. A.M. clinics, although attendance has fallen  
off. Kevin was elected to FS Technical Planning  
Committee. His WPHS team placed high in FHSAA  
State Championship. Our Feb. meet at OIYD drew  
over 600 swimmers and was an outstanding success  
due to hard work of parents. Looking ahead to  
coming year great emphasis must be placed on  
recruitment of 10 & Under boys by all branches.  
Best plan will be to hold Sat. A.M. tryouts and  
get flyers into 2-3 nearby elementary schools.
