## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF VISTA DEL LARGO ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, Fla. Stat., Vista Del Largo Association, Inc. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article 9, Section 9.2 of the Articles of Incorporation of Vista Del Largo Association, Inc. ("Articles of Incorporation") is hereby amended as follows (additions are indicated by underlining; deletions are indicated by strike outs, omitted and unaltered provisions are indicated by ellipses):

ARTICLE 9

## Amendments

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

Adoption. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approvals must be either (a) by not-less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association the affirmative vote of the majority of unit owners who are voting in person or by proxy at a meeting of the members of the Association at which a quorum has been attained (e.g., once a quorum of those unit owners attending in person or by proxy has been obtained at an annual or special meeting of the members of the Association, a majority of those unit owners attending the meeting in person or by proxy may amend these Articles of Incorporation); or (b) by not less than 80% of the votes of the entire membership of the Association an instrument signed by not less than a majority (i.e., 50% plus one) of the unit owners.

SECOND:

Adoption of Amendment: THIRD:

Article 9, Section 9.2 of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation may be approved by the affirmative vote of not less than 75% of the entire membership of the Board of Directors and by not less than 75% of the votes of the entire membership of the Association.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted this Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.
