AMENDED AND RESTATED ARTICLES OF INCORPORATION OF 2013 MAR - 5 PM 3: 05 COALITION OF BOYNTON WEST RESIDENTIAL ASSOCIATIONS, INC.

Approved by the Delegates on January 18, 2012

We, the undersigned, hereby associate ourselves for the purpose of forming a corporation, not for profit, under the laws of the State of Florida, and specifically pursuant to Chapter 617 of the Florida Statutes.

ARTICLE I - NAME

The name of the Corporation shall be COALITION OF BOYNTON WEST RESIDENTIAL ASSOCIATIONS, INC., hereinafter "COBWRA." The principal office of COBWRA shall be in Palm Beach County, Florida. The mailing address is PO Box 740814, Boynton Beach, FL 33474-0814.

ARTICLE II – PURPOSE

COBWRA is organized to:

- a) Form a coalition of homeowners', condominium and cooperative associations, hereinafter "Residential Associations," within the portions of Palm Beach County specified in the Bylaws as they may be amended from time to time.
- b) Serve as a civic association for the purpose of improving the quality of life within the areas as specified in the Bylaws.

ARTICLE III - CORPORATE POWERS

COBWRA shall have the power to do all acts consistent with attainment of the purposes of the corporation. In addition, it shall have, subject to any limitations contained in the Articles of Incorporation and Bylaws, all of the powers contained in Chapter 617relating to Corporations Not For Profit.

ARTICLE IV - MEMBERSHIP

Membership in COBWRA shall be limited to Residential Associations.

ARTICLE V - DIRECTORS AND OFFICERS

The affairs of COBWRA shall be managed by a Board of Directors ("Executive Board"). The number of directors, the duties of directors, and the method of election of directors shall be as stated in the Bylaws.

The officers of COBWRA shall be a President, such number of Vice Presidents, a Secretary, a Treasurer and such other officers, all as may be provided in the Bylaws.

ARTICLE VI - CORPORATE TERM

The term for which the Corporation shall exist shall be perpetual.

ARTICLE VII-BYLAWS

COBWRA shall establish Bylaws. The Bylaws may be altered, amended or rescinded in the manner provided in the Bylaws.

ARTICLE VIII – AMENDMENTS TO THE ARTICLES

- 1. Proposal: Amendments to these Articles of Incorporation may be proposed only by the Executive Board or by a petition signed by at least one-third of the membership. All proposed amendments to these Articles of Incorporation shall be submitted in writing to all Members by mail at least thirty (30) days before a regular or special meeting, at which the proposed amendments may then be read and acted upon with or without amendment.
- 2. Adoption: A vote of a majority of the entire Membership at a regular or special meeting shall be required to adopt any proposed amendment to these Articles of Incorporation.
