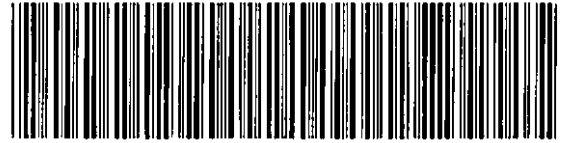

Amendments to the Articles of Incorporation
of Faith Creation Fellowship, Inc.
Document Number 762495

Article Five Shall read as follows:

Any person who is over sixteen (16) years of age and who has a bona fide, born-again experience, and who supports the church with both attendance and finances and has subscribed to the statement of Faith and who has agreed to comply with all provisions of the Articles of Incorporation and Bylaws and any amendments thereto may be considered a member. Existing members of the Board of Directors are the voting members, qualified to elect the Board of Directors at each special or regular meeting. Members shall not receive any stated salary for their services as such, but, by resolution of the Board of Directors, a fixed reasonable sum or expenses of attendance, if any, or both, may be allowed for attendance at each regular or special meeting. The Board of Directors shall have the power, in its discretion, to contract for and to pay to members rendering unusual or special services to the corporation, special compensation appropriate to the value of such services. No member shall be entitled to share in the distribution of the corporate assets upon dissolution of the organization.

Article Nine, Section C. Shall read as follows:

Upon Dissolution of this organization and winding up of its affairs, its assets shall be distributed exclusively for charitable or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Service Code of 1954, as amended, or any superseding section.
