**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
FIRST BAPTIST CHURCH OF WELLINGTON, INC.**

Pursuant to Section 617.1006, Florida Statutes, the **FIRST BAPTIST CHURCH OF WELLINGTON, INC.** (the "Corporation"), hereby amends its articles of incorporation as follows:

1. The name of the Corporation is **FIRST BAPTIST CHURCH OF WELLINGTON, INC.**
2. **Article XIII, Dissolution**, of the Articles of Incorporation of the Corporation is hereby removed and replaced in its entirety with the following:

**Article XIII  
Dissolution**

In the event of dissolution, all assets, real and personal, shall revert to the First Baptist Church of West Palm Beach, Florida d/b/a Family Church, so long as this entity is qualified as tax exempt under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of a future United States Revenue Law.

3. This Amendment was adopted by vote of the members at a meeting of the members on September 29, 2024. The vote of members in favor of this amendment was sufficient to approve the amendment.

4. This Amendment shall become effective upon filing.
