





To Whom It May Concern:

In April, 2007 we sent in the Annual Report for Spinnaker's Reach II Condominium Association with a check for \$61.25. We assumed, because the check cleared, that everything on the report was fine. When 2008 Annual Report time arrived we did not receive the document. Upon inquiry of the matter, we found out that we had been dissolved due to an incomplete application. Your office sent us a letter, but we never received it and because of the check clearing we had no reason to believe there was a problem.

Once we understood what had happened, I spoke with someone in your office that said to fill out a reinstatement form and send with it the \$61.25 fee for 2008. I was told that because you had received our check in 2007, we did not need to send the additional reinstatement fee. We then sent our 2008 reinstatement form with the \$61.25. Once again, our application was sent back to us. Florida Dept. of State cashed our 2008 check also but sent us a letter saying that we needed to send in the reinstatement fee. Once again I called your office. I was told by Barbara that I should explain all of this in a letter and send the application back again. She said that based on our explanation in this letter that once again we did not have to pay the reinstatement fee.

I have enclosed our application with this letter. You have already received and cashed our Annual Report fee checks for 2007 and 2008. If we need to do anything in addition to what I have done here, please contact me as soon as possible, so that we can be reinstated and put this matter to rest. Thank you for your attention to this matter.
